## Attention: You May No Longer Need to File State Copies of Reports

On October 14, 1999, the Commission approved a state filing waiver program that relieves most political committees of the obligation to file copies of federal campaign finance reports with certain qualified states. The states currently qualified are:

Because these states have agreed to disclose campaign finance information by providing public access, via computer, to the FEC's web site, which displays the reports of most federal candidates and committees, they no longer have to make paper copies of FEC reports available to the public. As a result, most political committees will no longer have to file copies of their reports at the state level in the states that have received the waiver.

**The exception is Senate candidates and committees. They must continue to file copies of their reports with the states.**

For more information, see the January issue of the *FEC Record*. Further details, along with the names of additional states that become certified, will be announced in future issues of the *Record* and on the FEC Web site.


