I take the Federal Election Commission reporting process very seriously. Upon discussion of outstanding issues with Allen Norfleet, Senior Campaign Finance Analyst on Monday the 9th of August, 2010, I have added additional safeguards to insure accurate and timely reporting. Upon filing the quarterly report of 01/01/10 - 03/31/10 I was confident all the necessary reporting had been successfully completed.

Allen Norfleet has worked with me on several issues and has clarified my thinking on a regular and ongoing basis. I found him to be very helpful and extremely knowledgeable. Since I am new to the unique Federal Election Commission reporting system I depended heavily on the instructions published at the F.E.C. website and guidance received.

Therefore, I was very upset when I received a compliance letter from the F.E.C. I believed the Minuteman Victory PAC would be small and easily handled, I had no idea the PAC would be a growing success and more than I had bargained for, not only in reporting but also in compliance. I have done my due diligence in compliance. When I had a question or clarification I called Allen Norfleet many times and he would readily answer and give guidance, the phone record proves my point.

On August 6th I received in the mail, to my horror, a letter which was sent to me from the F.E.C. office, however, the envelope and the letter was dated on June the 9th, 2010. I couldn't believe that it took 2 months for this letter to be delivered. To make matters worse, the response due of July 14th, 2010 had already passed. By the time I was able to place a telephone call, the F.E.C. offices were already closed, the California time zone gave me a 3 hour disadvantage.

On Monday I called Allen Norfleet and explained to him I was unaware that I was not in compliance and why it took 2 months for a letter to be delivered from the F.E.C. After the discussion and clarification of the issues I realized some of the F.E.C. concerns have already been addressed at an earlier time, but the outstanding 48 hour notices were not.

Therefore, I have set up a notification system with my direct mailing house so they can notify me upon the sending date of any direct mail from their facility. This new notification process will assist in a timely filing of any notice.

I have a strong history of asking for assistance, and even through I am new to F.E.C. reporting methods, I am confident that with the new notification system I have put in place, will assist me in filing in a timely manner.

Please accept my apology in this matter and I will strive to file in a timely manner and stay in compliance.

I am filing my 48 hour for Southwest Publishing as per conversation with Allen Norfleet today.
