In response to your letter, Identification Number C00139360, we are sending the first 5 pages of Amended Form 3X for the period covering April 1, 2012 through June 30, 2012. We found the following while amending this report:

Line 6(c) Column B is correct from the original report. The sum ties to the amount reported on the March 31, 2012 report plus the amount reported in Column A for the June 30, 2012 report.

Line 31, Column B – on the original report covering April 1, 2012 through June 30, 2012, the total was not filled in. The amounts listed on the report do tie to Line 7 Total Disbursements, however the total for line 31 was inadvertently left blank. That amount is corrected on the amended report.

In reference to contributions to Federal candidates and committees, we will in the future list only Federal expenditures on Line 23. Past reports dating back through 2005 have all listed the state contributions on Line 23, but future reports will have state expenditures listed on Line 29.

We believe this amended report and letter will clear up any discrepancies on the Form 3X for April 1, 2012 through June 30, 2012.

Contributions to non-federal candidates and committees should be itemized on Schedule B supporting Line 29.
