The following statement documents the purpose for filing this amendment: On October 9, 2008 the PAC discovered that one of the member companies of the National Marine Manufacturers Association had been collecting payroll deductions for the PAC on a regular basis since January 2008. During the period of January 1 – September 30, 2008 payroll deductions in the amount of \$483 were withheld from the wages of employees of this member company. The PAC treasurer was unaware that such funds had been withheld and not forwarded as required. Consequently, the payroll deductions were not included in the reports that were originally filed with the Commission. Upon discovery of the exception and in accordance with Advisory Opinion 1999-33, funds were immediately forwarded to the PAC treasurer and steps taken to file amendments to all reports impacted by the deposit of these payroll deductions. Steps have been taken to ensure that such payroll contributions from member companies will be forwarded and reported timely.
