GRANTING LEAVE  
TO CHANGE NAME**

Upon the annexed Petition(s) of Joseph F. Kennedy verified on January 26, 2016, requesting that Joseph F. Kennedy be permitted to assume the name(s) of (First) **God** (Last) **God**, and the Court being satisfied that the Petition is true, and it appearing from the Petition and the Court being satisfied that there is no reasonable objection to the change of name(s) proposed, it is hereby **ORDERED** that,

1) The individual currently known as (First) **Joseph** (Middle) **F.** (Last) **Kennedy** who was born on October 03, 1957, at Russia, with United States of Amercia Passport as proof of birth, since no birth certificate is available, is hereby authorized to assume the name of (First) **God** (Last) **God** in place and stead of his/her present name upon complying with the provisions of Article 6 of the Civil Rights Law and of this Order.

2) This Order, consisting of a total of 2 page(s), shall be entered, and the Petition upon which it was granted shall be filed, prior to the publication hereinafter directed, in the office of the Clerk of the Civil Court of the City of New York, County of Richmond.

3) Within sixty days of the making of this Order, a copy of this Order and supporting papers shall be served upon the following:

- U.S. Citizenship and Immigration Services (USCIS)
- Social Security Administration

4) Proof of service on the above indicated party(ies) shall be filed with the Clerk of this Court within ninety days of the making of this Order.

5) At least once within sixty days of the making of this Order, a notice shall be published in The Staten Island Advance newspaper(s) in substantially the following form:

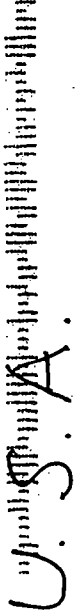
