To Whom It May Concern:

This letter is to inform you of the multicandidate status of Armenian National Committee Political Action Committee (ANC-PAC), a nonconnected political action committee. The ANC-PAC board recently discovered during an audit that ANC-PAC had not filed FEC Form 1M. Enclosed is a completed copy of that form indicating that upon completion of our audit, we discovered that the ANC-PAC has qualified as a multicandidate PAC since at least December 31, 1993 yet had failed (we believe upon examining public records on the FEC website) to file a Form 1M.

The ANC-PAC recently appointed a new board of directors who conducted an audit of the books and reports filed by the ANC-PAC since its inception in 1993. The audit indicates that by December 31, 1993, the ANC-PAC had received contributions from at least 51 persons, had been registered with the FEC for at least six months, and had made contributions to at least five federal candidates. Accordingly, ANC-PAC qualified as a multicandidate committee by December 31, 1993.

The new ANC-PAC board believes that all contributions made by the ANC-PAC have been in accordance with FEC guidelines. Further, the new board has instructed the treasurer to indicate on the summary page of each report filed with the FEC that ANC-PAC has qualified as a multicandidate committee.
