In response to your inquiry dated April 11, 2001, enclosed please find an amended report for the period 10/19/00 through 11/27/00. In response to your first question, a total of \$8,880.70 has been transferred back to the non-federal account, leaving a transfer balance of \$527.10. The report has been amended accordingly. I apologize again for the error. A miscommunication between my assistant and myself caused the amounts to be transferred more than once.

Finally, with respect to the last question regarding ASPAC's contributions to Rep. Hastings, our records do not indicate that ASPAC contributed more than \$5,000 to either the 2000 primary or general elections. You will note that the ASPAC contribution to Rep. Hastings in June of 2000 was for 1992 General Debt Retirement. The report noted only 1992. An amendment has been included to clarify the designation of this contribution.
