Employee Federal Political Action Committee ( SBC EmpAC ) As you were notified on May 10, 2005 by Angela Hanratty and Diane Hawkins, Associate Directors - Federal Relations of this office, it has recently come to the attention of the SBC EmpAC that during the time period of 2001 through 2004, certain foreign nationals employed by the subsidiaries of SBC Communications Inc. inappropriately made contributions to the SBC EmpAC. These contributions were in derogation of the PAC authorization forms which admonish that foreign nationals are legally prohibited from making PAC contributions. This discovery was made on May 6, 2005 as a result of an internal company audit. Attached hereto is a list of these 45 individuals and the amounts contributed. Refunds of these contributions were mailed to the individuals involved on May 16, 2005 and will be reflected on the June 20th Monthly Report to the FEC. SBC has taken further preventative measures in an attempt to keep these contributions from occurring in the future or, in the event our process inadvertently fails, to identify and refund these monies quickly.
