This Amendment is in response to the Commission's request, dated April 29, 2009. 1. The Summary Page totals have been corrected with this report. 2. The vendors on our Line 15 receipts have not appeared before because the Parent Companies wrote the refund checks to the Committee. These have been corrected to show the subsidiary that we originally made disbursements to. 3. The Committee has not received any disbursements from the Dollars For Democrats. Unlike the other joint fundraising committees, the D4D does not make regular disbursements. The Committee hopes to receive a transfer from this committee in the coming months. 4. All fundraising expenses were for the benefit of the Committee and not directly for a federal candidate. 5. Purposes have been updated for expenses on Schedule H4. 6. The Committee has made regular disbursements for administrative expenses. The only difference is that the Committee now owns its own building and no longer makes rent payments. This report includes Memo Schedule A entries for contributions raised by the ASDC Partnership program, Dollars for Democrats, and the AR Party Victory Fund. The committee has not received its share of the proceeds as of the end of the reporting period. The committee expects to receive the transfer at some point in the three months following this reporting period. Any payroll related items on Schedule H4 were for employees that did not spend over 25% of their compensated time on federal activity. Any events or fundraising activity was for the benefit of the Committee and did not support a federal candidate.
