Federal law requires us to use best efforts to collect and report the name, mailing address, occupation and name of employer of individuals whose contributions exceed \$200 in an election cycle. Contributions to Harriman for Congress are not tax deductible for federal income tax purposes. Contributions are limited to personal funds of \$2,500 per person for the Primary 2012 election and \$2,500 for the General 2012 election. Contributions from qualified Federal PACs are limited to \$5,000 per PAC for the Primary 2012 election and \$5,000 for the General 2012 election. Contributions from foreign nationals and corporations are not permitted.
