I am responding to your letter dated March 28, 2001 concerning the Mid-Year Report (1/1/01-6/30/01) for the Caterpillar Employees Political Action committee. When the first letter from Mr. Jim Krebs concerning this report was received in February, our PAC Administrator, Cresta Heltemes, talked to Mr. Krebs.
