Thank you for your letters of November 17 and 19, 1993, bringing to my attention the contribution referenced in the March '93 Monthly Report, Identification Number C0004275 and the signature of me or my designated agent also referenced in the same report as well as the February '93 Monthly Report and October '93 Monthly Report.

I understand you have spoken with Meg Bonitt from my staff. As she discussed with you, I will report our December '93 FEC report to show that the contributions to the "Lauch Faircloth for Senate Committee" should be redesignated as follows:
