On May 10, 1995 you were notified that a review of the above-referenced report(s) raised questions as to specific contributions and/or expenditures, and the reporting of certain information required by the Federal Election Campaign Act.

Your May 22, 1995 response is incomplete because you have not provided all the requested information. For this response to be considered adequate, the following information is still required.

-The total listed on Line 11(a)(ii), Column B of the Detailed Summary Page appears to be incorrect. Please be advised that you should add the "Calendar Year-to-Date" total from your previous report to the current "Total This Period" figure from Column A to derive the correct Column B totals. Your previous report discloses blank for Column B, Line 11(a)(ii) while this report discloses \$891.50 for Column A and \$2,310.00 for Column B, Line 11(a)(ii). Please amend your report accordingly.

If this information is not received by the Commission within fifteen (15) days from the date of this notice, the Commission may choose to initiate audit or legal enforcement action.
