If this disbursement(s) constitutes a communication to your restricted class which is exempt from the definition of contribution and expenditure under 11 CFR §114.3, it should be disclosed on Line 29 of the Detailed Summary Page. Furthermore, the purpose of each disbursement should include the type of expense, the name, office sought, state, and district, if applicable; of each federal candidate identified in the communication, and a statement that the expense is for an internal communication to the restricted class (see Advisory Opinion 2000-3). Please amend your report to properly disclose this activity or provide clarifying information.

**Please note, you will not receive an additional notice from the Commission on this matter.** Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. **Requests for extensions of time in which to respond will not be considered.**
