Dear Sir or Madam:

I have written this letter to explain the contents of this mailing and eliminate any possible confusion. I have enclosed three (3) items:

1. Amended Cash on Hand Reports for September, October, and November reports

- Due to an accounting error in the September 20 (M9) Report covering period 8/01/2006 8/31/2006, the cash on hand amounts for that and all following reports were reported as too great amounts – the cash on hand amount for the beginning of the August month was reported as \$84.31 too high. The resulting incorrect cash on hand amount at the end of that period carried over to forthcoming periods, causing every cash on hand reported amount since that time to be \$84.31 too high. Therefore, I have attached Amended Cash on Hand reporting pages (Page 2 of Form 3x) for August and September months that report the cash on hand amounts correctly. A corrected cash on hand for the October period can be found within the amended report for that period as well.

2. Amended November 20 (M11) Report covering period 10/01/2006 – 10/31/2006

- A contribution and an expenditure were left out of the M11 November 20 report due to an accounting error; this amended report itemizes those omissions and adjusts the total contribution and expenditure amounts accordingly.

3. New December 20 (M12) Report covering period 11/01/-2006-11/31/2006

- This report covers the November month as per the committee's monthly reporting duties.
