Dear Mr. Dobi:

This statement is in response to the Commission's letter dated May 13, 2021 regarding five (5) items.

First, the Commission's letter requests clarification on four (4) contributions identified as possible corporations or labor organizations. In all four (4) instances, these contributions were refunded to the contributors.

Second, the Commission's letter requests clarification regarding thirty-six (36) contributors disclosed on the Original Report that appear to exceed federal contribution limits. As described below, all of those contributions were refunded to the contributors, returned to a joint fundraising committee ('JFC') in which the Committee participates for proper reallocation, or clarified as will be reflected on subsequent reports. Twenty-seven (27) contributors had their excessive contributions refunded. Seven (7) of the contributors had their excessive contributions returned to the joint fundraising committee (Perdue Victory, Inc.- C00571620, Team Perdue - C00578542, or Senate Georgia Battleground Fund

C00736967) from which they came, to be reallocated to other JFC participants. The Commission identified one (1) apparent excessive contribution from a committee. This contribution was returned to a JFC in which our Committee participates. The Commission identified one (1) excessive contribution from a Non-Qualified PAC. This contribution was returned to a JFC in which our Committee participates.

Third, the Commission's letter requests clarification on a contribution from one (1) LLC (limited liability company). The Committee has confirmed that this contributor used federally permissible funds.

Fourth, the Commission's letter requests clarification on four (4) contributions identified as Non-Federal Committees. One (1) contribution was refunded to the contributor. The committee has confirmed that the three (3) remaining contributors used federally permissible funds.

Fifth, the difference between the amount transferred from Senate Georgia Battleground Fund (C00736967) and the individual memo entries supporting the transfer constitute unitemized contributions. To the best of the Committee's knowledge, none of the unitemized contributors exceeded \$200 in aggregate for the calendar year. The Committee conducts continued and routine donor record maintenance. If during this routine donor record maintenance, the Committee identifies and merges the records of duplicate donors, the Committee will amend its report to reflect proper aggregates. The Committee has added memos to disclose the unitemized amount in each transfer.
