-Your calculations for Line 30, Column B appear to be incorrect. FEC calculations disclose this amount to be \$506.30. Please provide the corrected total on the Detailed Summary Page.

-Your report discloses activity that falls outside the reporting period. Please amend this report by including only the financial transactions that occurred between 11/29/94 and 12/31/94. Any activity occurring outside this reporting period should be included in the appropriate report(s). 2 U.S.C. §434(b)

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this
