FEC Commission:

We hereby disavow knowledge of any campaign funds collected from a website named milesfor senate. No one other than the committee on file with Yolanda Brown as treasurer for me the candidate Steen Miles has authority to receive funds and should not impact in any way our financial disclosures. We have not yet reached the threshold of \$5,000 for filing, but were advised to submit the paperwork in order to properly collect funds.

On October 19, it was brought to my attention that there was a risqué video on my website for U.S. Senate. On initial investigation, I found an alternate website had been set up with a milesfor senate address, a different home page look and a donate page but with content lifted from my authorized site.

On further investigation by my authorized web designer, we found that the site was set up on September 17, 2013 in the name of a Claudia North with an Atlanta address of 1370 Hanover West Drive 30327. A cease and desist letter was sent via email to Richard North with a copy to Robert Patillo, two individuals who were associated with the campaign but were never given authority to set up a separate website or receive funds in the name of or apart from the Steen Miles for U.S. Senate campaign.

We continue to explore other legal remedy but are not able to make an accounting of any funds that might have been received or assess damage done to our reputation.


