
Dear Ms. Winship:

This letter is in response to your letter dated September 5, 2007 concerning our contributions to the "Stevens for Senate" 2008 general election campaign. As a consequence of your letter, we have requested and have received an expeditious refund of \$3,500 from "Stevens for Senate" 2008 general election fund. Attached are copies of the refund request letter, the refunded check, and the deposit slip dated 9/18/2007. As required, we will report the refund on Schedule A, supporting line 16, in our next report covering the period July to December 2007.

The total amount contributed to the "Stevens for Senate" 2008 election cycle by the Oshkosh Truck Corporation Employees' Political Action Committee was \$10,000. The excess you have identified for the general election was a reporting error, not an attempt to exceed the general election limitation. We have reviewed our reporting procedures and have made changes to our review process to ensure this filing error is not repeated.

It was and is now the intent of the Oshkosh Truck Corporation Employees' Political Action Committee ("OTCEPAC") to adhere strictly to all federal campaign finance laws. This letter and enclosure constitutes our response to the FEC's letter dated September 5, 2007.

The Oshkosh Truck Corporation Employees' Political Action Committee (OTCEPAC) was notified by the Federal Election Commission in a letter dated September 5, 2007 that the OTCEPAC exceeded the contribution limits set forth in 2 USC 441 a(a) to the "Stevens for Senate" 2008 general election committee. The attached letter from the Federal Elections Committee indicates that OTCEPAC contributed \$8,500, which is \$3,500 in excess of legal limits.

It was and is now OTCEPAC's full intention to strictly follow all federal election campaign finance laws and therefore requests the Stevens for Senate Committee expeditiously refund to OTCEPAC \$3,500 and report the refund to the FEC accordingly.

Dear Treasurer:

This letter is prompted by the Commission's preliminary review of the report(s) referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. **Failure to adequately respond by the response date noted above could result in an audit or enforcement action.** Additional information is needed for the following item:

-Schedule B of your report (see attached) discloses one or more contributions which appear to exceed the limits set forth in the Act. 2 U.S.C. §441a(a) prohibits a multicandidate committee and its affiliates from making a contribution to a candidate for federal office in excess of \$5,000 per election.

If any apparently excessive contribution in question was incompletely or incorrectly disclosed, you should amend your original report with clarifying information.

If any contribution you made exceeds the limits, you must request a refund of the excessive amount or provide a written authorization for a redesignation of the contribution pursuant to 11 CFR §110.2(b) within 60 days of the treasurer's receipt.

If the foregoing conditions for redesignations were not met within 60 days of the treasurer's receipt, your committee must obtain a refund of the excessive amount.


Please inform the Commission of your corrective action immediately in writing and provide a photocopy of the refund or redesignation request sent to the recipient committee(s). In addition, any refunds should be disclosed on Schedule A supporting Line 16 of the report covering the period during which they are received. Any redesignations should be disclosed as memo entries on Schedule B supporting Line 23 of the report covering the period during which the redesignation is made. 11 CFR §110.1(b)

Although the Commission may take further legal action regarding the excessive contribution(s), your prompt action in obtaining a refund and/or redesignating the contribution(s) will be taken into consideration.

**Please note, you will not receive an additional notice from the Commission on this matter.** Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. Requests for extensions of time in which to respond will not be considered.

Electronic filers must file amendments (to include statements, designations and reports) in an electronic format and must submit an amended report in its entirety, rather than just those portions of the report that are being amended.
