I am combining my response to your letters of April 1, 2005 because meeting the reporting requirements for the September Monthly Report (7/1/04—8/31/04) affected the totals for the October Monthly (9/1/04—9/30/04 and 12 Day Pre-General (10/1/04—10/13/04) Reports. 
