This is in reply to your letter dated January 12, 2000, regarding the above referenced monthly report, specifically the refund listed on Schedule B to DSI Constructors, Inc, in the amount of \$1,627.22.

Our records indicate that on March 15, 1999, we received a check for \$15.32 (deposited 3/18/99), on April 15, 1999, we received \$20.68 (deposited 4/22/99), on May 14, 1999, we received \$403.22 (deposited 5/20/99), and on June 14, 1999, we received \$1,188.00 (deposited 6/17/99), from DSI Constructors, Inc., along with correspondence indicating donations from union members under their employ. These monies were deposited into our CAF account and subsequently reflected in our April Report (3/1/99 - 3/31/99), May Report (4/1/99 - 4/30/99), June Report (5/1/99 - 5/31/99), and July Report (7/1/99 - 7/31/99) as unitemized contributions. It was not necessary to itemize these contributions as they did not exceed the \$200.00 allowed per calendar year per individual.


MEMORANDUM
