As I have not heard back from you on the filing of the amendment for the state committee nor on my request to consolidate the accounting nor on my subsequent requests for status reports I am going to terminate our agreement. It is my opinion that it will be best for Merced DCCC to have all of it's accounting and filing done from your location.

I know Sheryl White at Statecraft would be able to (fairly easily) get you up and running on Statecraft and you could do the State and Federal efilings yourself. If you do this with Sheryl I can archive the database and send it to you to restore and you will be ready to hit the ground running. (State - from 12/31/04 and Federal from 4/30/05)

I am going to bundle up all of the files I have and ship them to you along with the remaining check stock and deposit slips. The federal committee owes WALLC \$462.50 for which I will issue a check today. There will be one final closing invoice for the filing of the monthly report today which I will mail to you.

In addition, I am currently the treasurer of the federal committee. Per the FEC instructions your new treasurer should request a password and amend the Statement of Organization to reflect their new status as treasurer. I am attaching a PDF file of the FEC instructions about appointing a new treasurer. I did not find the instructions to be extremely clear so you may want to ask Ash for direction on this.

Your next federal filing will be due June 20, 2005 for the month of May.
