All memos now correspond with the original disbursement. 3. In reference to the letter received regarding the clarification of the description for Dr. Milton Clement, the report has been amended to reflect that the disbursement was made for Dental Care. 4. In regards to the letter received referring to voided or returned checks the report was amended to incorporate the following memos: Melissa Lamkay: Check issued in error. Melissa Lamkay: Duplicate payment- paid on 10/30/06. Karen Thurman: Check issued in error.- .Transfers received from the DNC, DCCC, DSCC and candidate committees, not including ASDC/Dollars for Democrats and DNC Victory Fund, were not for joint fundraising. None of the transfer in money received from the DNC or DCCC was used in the payments made for exempt activities. None of the expenses listed on Line 21b were public communications or FEA activities. None of the expenditures listed on Line 30b were expressed advocacy. The payments listed on H4, including all consulting fees, were administrative/committee fundraising expenses and not FEA nor in connection with a federal election. Payroll and all related expenses reported on Schedule H4 were for staff that did not spend more than 25% of their time on FEA or in connection with a federal election.
