To whom it may concern:

I originally tried to submit the attached report this evening via your online system using the ID number that I found when I tried to submit my report on the 21st. Unfortunately that number was a C9xxx number assigned to us for submission of Form-5. When I tried to use that number to submit a Form-9 I received an error letting me know that I could not submit a Form-9 using a C9xxx ID.

This information was neither communicated to me nor the fact that we needed to be assigned a different number, a C3xxx number, in order to submit Form-9. Because I received that error after trying to submit our online filing, and only because of that, I searched again for information about what to do and discovered we had been assigned a different number. There was no communication with me about that and there was no direction to look for that until I received your system error.

Unfortunately the password we requested, that took three days to acquire, works for our C9xxx id number but not for our C3xxx id number. So, we are unable to submit our report online and are submitting it as an attached fax.
