The Renal Leadership Council PAC does have very limited administrative expenses because the PAC is administered as part of a broad contract of services provided by Congressional Consultants (CC) for the Renal Leadership Council (RLC). Services to administer the PAC by CC on behalf of the RLC are not broken out or separately reimbursed by the RLC. Instead, the RLC pays a global monthly fee to CC for a broad range of government relations services. The RLC is not a formal organization. CC spends very little time administering the PAC. Having talked to Jim Krebs, Reports Analyst at the FEC, it was decided that in lieu of listing a salary, as one is not paid for administering the PAC, that the RLC should list an in-kind contribution to the RLC PAC for the administration of the PAC. As a result, a \$200.00 in-kind contribution from the RLC to the RLC PAC is noted here.

Check #2063 in the amount of 55,000.00 to the Committee for the Preservation of Capitalism dated 5/21/02 was voided on 7/7/02 and was never cashed. The disbursement was recorded in the July 15 Quarterly Report. Since the check was voided after the close of the reporting period for the July Quarterly Report, the October 15 Quarterly Report lists the transaction as a negative entry.
