Dear Ms. Rocco:

This is in response to your letter dated November 7, 2008 concerning the October Quarterly Report (7/1/08-9/30/08), of the above reference Committee.

1. The expenditures made for "Catering/Facilities" and "Consult/Fundraising Profess. Services" on Schedule B were for fundraising activities of the Committee, not on behalf of federal candidates.
2. The expenditure(s) disclosed on Schedule B for "Printing" were made for fundraising activities of the Committee, not public communications or voter drive activity containing express advocacy.
3. Voices for a Senate Majority is a joint fundraising committee by and between Tom Allen for Senate, Alaskans for Begich, Al Franken for Senate, Hagan Senate Committee, Inc., Udall for Colorado, Jeff Merkley for Oregon, Jeanne Shaheen for Senate, Udall for Us All, and the Democratic Senatorial Campaign Committee, all are political committees registered with the Federal Election Commission. The Committee was formed solely to conduct a joint fundraising program, and thus has few administrative expenses. All expenses incurred as a result of the joint fundraising program and any administrative costs incurred as a result of that program have been reported as federal expenditures by the Committee.

Voices for a Senate Majority paid the Democratic Senatorial Campaign Committee for legal and administrative expenses on July 29, 2008, September 2, 2008, and September 19, 2008. These payments are reflected in the October Quarterly Report (7/1/08-9/30/08).
