Dear Mr. Jones

This is in response to your letter of February 20, 2009, regarding a contribution from the American Academy of Family Physicians Political Action Committee (FamMedPAC) to the Udall for Colorado campaign.

FamMedPAC originally made a \$5,000 contribution to the Udall for Colorado campaign on May 15, 2008, designated for the General Election. We received a request from the campaign on October 24, 2008 to re-designate this contribution to the Primary Election so that FamMedPAC could make a \$5,000 contribution to the General Election at that time. We signed a re-designation letter and forwarded it to the campaign. The redesignation was also noted on our Amended 30-day Post General Report (page 37, items B and C). We have now learned that this redesignation was beyond the 60-day time limit for redesignating a contribution once it is received by the campaign. Because the redesignation was not allowed, FamMedPAC made a total contribution to the Udall for Colorado campaign for the General Election of \$10,000. This is \$5,000 over the contribution limit for the General Election.

FamMedPAC requested and received a refund of this \$5,000.

Attached is a copy of the original check from FamMedPAC to the Udall for Colorado campaign for the General Election from May of 2008, the redesignation letter for this contribution, the letter from FamMedPAC requesting a refund, the letter from the Udall for Colorado campaign in response to our request, and a copy of the refund check from the Udall for Colorado campaign to FamMedPAC.


