Dear Mr. Lundquist:

On March 29, 1995 you were notified that a review of the above-referenced report(s) raised questions as to specific contributions and/or expenditures, and the reporting of certain information required by the Federal Election Campaign Act.

Your April 5, 1995 response is incomplete because you have not provided all the requested information. For this response to be considered adequate, the following information is still required.

-Your amended 1994 Year End Report shows \$1,000 designated as a contribution toward reducing general election debt incurred by the Alaskans for Don Young committee. According to FEC reports, Alaskans for Don Young incurred no debts from the 1994 general election and would therefore be ineligible to receive contributions for the purpose of reducing debts attributable to that election. Please clarify this contribution and disclose any redesignation or refund as necessary on the appropriate schedules.

If this information is not received by the Commission within fifteen (15) days from the date of this notice, the Commission may choose to initiate audit or legal enforcement action.

As per our discussion regarding the Calcot Fedpac contribution to Congressman Young in December of 1994 of \$1,000 for 1994 campaign debt reduction...we request that you redesignate that contribution and designate it toward the 1996 primary election.
