Dear Mr. Morse:

This letter is in response to your correspondence dated April 30, 2010 surrounding questions you have on the 2009 Year End Report of The Dayton Power and Light Company Employees' Fund For Responsible Citizenship (the "Fund"). Based upon the explanation as set forth below, the Fund has attached amended summary pages of two reports: the 2009 Mid-Year Report and the 2009 Year End Report. From our review, it appears that although the summary page 2 of each 2009 Summary Report accurately reflected the Fund's status, some of the underlying detail in both reports was inaccurate. Therefore, we are attaching both summary reports for 2009 to correct these errors.

2009 Mid-Year Report

Here are the amendments to this summary report:

- A. Page 4, line 23: the \$23,635 dollar is now properly shown on line 23 and not line 22. In addition, the dollar amount reported in the original report on line 22 was incorrectly listed as \$25,635 versus the correct amount on line 22 of \$23,635 of the amended report. This amount reflects the amount distributed to federal candidates and committees as corroborated by the detailed pages originally filed with this report.
- B. Page 4, lines 31 and 32, Columns A and B: the amount shown on the amended report reflects the corrected total Federal Disbursements for the first half of 2009 (\$23,161.72) versus the incorrect amount of \$24,761.72 originally filed.

C. Page 5, line 36, Column B: the amount shown on the amended report reflects the year-todate Federal Operating Expenditures of <\$473.28> which were not completed on the original filing.

2009 Year End Report

Here is the amendment to this summary report:

A. Page 4, lines 31-32: these lines were not completed in the original filing. As amended, lines 31-32, Column A now reflect the total Federal Disbursements for the second half of 2009 (\$3,850) and lines 31-32, Column B now reflect total Federal Disbursements as of the end of 2009 (\$27,011.72).




