Dear Mr. Ryan,

Enclosed are amendments to our filings for 2000.

The Federal Independent Campaign Committee did not provide any direct candidate support to any candidate in the 2000 elections. The H3 and H4 forms we filed that indicated direct candidate support were in error. We have resubmitted them, classifying all of our expenditures and transfers from our state committee as administrative expenses. The year-to-date totals for administrative expenses are reflected on our amended H4s.

The debt reported on line 10 of our July quarterly, October quarterly, post-General, and year-end reports had been correctly reported on Schedule C on our April quarterly, but erroneously reported on Schedule D on later reports. We are including the Schedule C for those 4 reports.

The \$14,480.00 returned check on Schedule A of the April quarterly was not redistributed to our state campaign fund because it was later re-issued to the payee.

Please be assured that these errors resulted from honest misunderstanding of the multitude of complicated instructions for the Form 3X and its attachments, most of which do not apply to our small campaign committee. I appreciate the help you and Scott Walker provided to me in completing the amendments and hope I have done everything satisfactory.
