

Dear Mr. Jones:

Cassidy & Associates is the trade name of the division of CMGRP, Inc. which is connected to the CMGRP, Inc./Cassidy & Associates Political Action Committee, a separate segregated fund. Section 5 of the amended Statement of Organization filed on September 13, 2007 should not have identified Cassidy & Associates. It should have identified CMGRP, Inc. d/b/a Cassidy & Associates as the connected organization of the separate segregated fund. The address in section 5 is correct. We changed the name of the PAC to CMGRP, Inc./Cassidy & Associates Political Action Committee in reliance on AO 2002-04 in which the same approach was followed by Austin, Nichols & Co., Incorporated/Pernod Ricard USA Political Action Committee. If you agree, we will amend the Statement of Organization to correct the information in section 5. In other respects, we believe the Statement of Organization is correct.
