Our office acts as campaign counsel to the above referenced filer. This Form 99 submission is being filed to update the Calendar-Year-To Date Per Election for Office Sought totals on the 24 hour reports filed October 24, 2012 and October 26, 2012.

On the 24 hour report filed October 24, 2012 the Calendar-Year-To Date Per Election for Office Sought total for independent expenditures supporting Barack Obama for President should be \$12,107.31 (not \$7,116.00 as originally reported).

On the 24 hour report filed October 26, 2012 the Calendar-Year-To Date Per Election for Office Sought total for independent expenditures supporting Barack Obama for President should be \$15,316.31 (not \$10,325.00 as originally reported).

The original cumulative totals did not take into account independent expenditures that occurred in the third quarter of 2012. This is because the original filing of the third quarter report was prepared and filed using an incorrect name and identification number (California State Council of Service Employees, ID# C90012287) due to a clerical error in our office. An amendment to that report is also being filed. We understand from a phone conversation with Rebecca Hough that this Form 99 submission is sufficient to update the public record regarding these amounts and that no further amendments are required.
