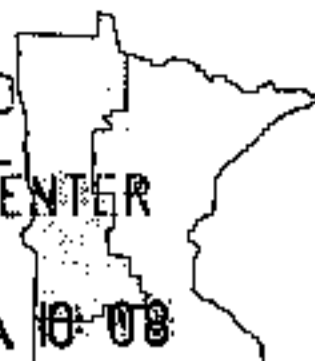

Per our recent phone conversation, I am writing in reply to your letter of April 13. This note is to certify that that the funds we received from the county committee donations listed on p. 3 of your letter are federally-permissible. While not typically registered with the F.E.C., local parties in Minnesota must file thorough disclosure reports with our state Campaign Finance Board, and so are prepared to document that the funds they raise do comply with federal limitations and prohibitions.

I am separately filing a revised Form 3 with the F.E.C. to establish that I have succeeded Edward Gatfield as Treasurer of this organization.
