Dear Ms. Benitz:

This letter is in response to your letter dated April 8, 2011. When the Carmeuse PAC was formed in March 2009 we were not aware that there was another Federal PAC in existence which was Dravo Corporation Employees for Better Government Fund (“Dravo PAC”), Identification Number C00038794. During 2010 we became aware of the Dravo PAC and discovered that it had been dormant since at least December 2002 with the only activity being interest income earned on cash in a bank account.

I contacted the Federal Election Commission during the third quarter of 2010 to determine whether it was possible to transfer the funds from the Dravo PAC to the Carmeuse PAC so that we could effectively consolidate the activity. I was told that it was okay to make the transfer of funds and to file a termination report for the Dravo PAC. During December we completed the transfer of funds and filed a Termination Report for the Dravo PAC. On March 8, 2011 we received correspondence from the Federal Election Commission accepting the termination filing (Copy Enclosed).

Your April 8th letter requests that I file an amended Statement of Organization listing the Dravo PAC on line 6. Given that the Dravo PAC has now been terminated do you still require an amended Statement of Organization?

Your letter also requests that an amendment to Schedule A be completed due to the transfer from the Dravo PAC exceeding the annual \$5000 limit. Given the explanation above please advise how I should proceed to correct the year-end report.
