After discussion with our analyst, it was determined that the MEMO box on 29 of the 30 disbursements (which were reported on Schedule D Debts and Obligations) filed with the 30 Day Post General report had been incorrectly left unchecked. The FECfile software would not allow either modification or deletion and reposting of these disbursements so the MEMO box could be checked and an amended Post General report could be filed. This will be corrected as soon as can be done. The Cash on Hand at close of period (Summary Page, line 8) should be \$142,957.30 when corrected, which will also be the opening Cash on Hand for the Year End report once amended reports can be filed..
