Any activity occurring outside this reporting period should be included in the appropriate report(s).

-The independent expenditure schedule (Schedule E) should disclose the following information: the name and mailing address of the payee, purpose of the expenditure, date of payment, amount of payment, the name and office sought of the federal candidate supported or opposed, signature of the treasurer, and notarized certification of the information provided. Please amend Schedule E by providing the complete date for each payment. 11 CFR §104.3(b)(3)(vii)

-Your committee reports disbursements on Schedule B and Schedule E which appear to be identical. Please note that independent expenditures should be itemized on Schedule E supporting Line 24 of the Detailed Summary Page. Duplication in reporting these expenditures may cause inflated disbursement totals. Please amend your report to clarify this discrepancy.

-Your committee has filed a 24 hour notice for an independent expenditure

supporting "George W. Bush/Dick Cheney" (pertinent portion attached). Twenty four hour notices of independent expenditures must be fully itemized on a Schedule E, in the next report filed by the committee. Please amend your report and any subsequent reports that may be affected by this correction.


Although the Commission may take further action concerning this matter, your prompt response will be taken into consideration. 11 CFR §104.4(a).
