Dear Mr. Decker:

We are writing in response to your inquiry dated December 8, 2004 regarding our FEC Form 278 report referenced above. The amount of \$13,547.34 disclosed on this report and questioned in your letter, which appears to be a transfer to a non-federal account of our committee, is not actually a transfer at all. Our Controller who prepares our FEC reports had realized that the cash balance disclosed on our report did not agree with our actual cash balance by \$13,547.34 and made an error in judgment by attempting to make this correction in one line item adjustment on the April 2004 report rather than doing the research to determine the reason for the difference and amending the report where the error occurred.

We have since researched this matter and determined that \$13,820.00 of contributions to the PAC were duplicated on two reports. These contributions were included on both the 12 day Pre-General report that covered 10/1/2000 through 10/18/2000 and the 30 day Post-General report that covered 10/19/2000 through 11/27/2000. These contributions were from early October 2000 and were correctly included on the first report, but the system we were using at the time assigned dates to these contributions of 10/19/2000 and 10/20/2000, which we believe were the dates that these were entered into our system. As a result, they were also included on the 30 day Post-General report in error. Today, we electronically filed an amendment to correct the federal receipts on the 30 day Post-General report for the 2000 year. We have also electronically amended the quarterly report that covers the first quarter of 2004 that is the subject of your inquiry. In the amendment, we removed the \$13,547.34 adjustment that appeared to be a transfer, but there is now an amount of \$272.66 shown as "other Federal receipts." Copies of both amendments are enclosed with this letter.

The one error described in the paragraph above accounts for the vast majority of the problem with the cash balance reported on our FEC reports. A portion of the remaining difference of \$272.66 pre-dates 1998 and cannot be identified and we believe the rest is now correctly classified as "other Federal receipts."


This letter is prompted by the Commission's preliminary review of the report(s) referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. **An adequate response must be received at the Commission by the response date noted above.** An itemization of the information needed follows:

-Schedule B of your report discloses a transfer totaling \$13,547.34 to what appears to be a non-federal account of your committee. Please be advised that committees that make disbursements in connection with federal and non-federal elections and have established separate federal and non-federal accounts, must allocate their expenses pursuant to 11 CFR §§106.6 and 106.7. Please provide further clarification regarding this transfer. The Commission recommends that you take steps to correct any non-compliance, and that you establish procedures to ensure future compliance with the allocation regulations.

Unlike previous election cycles, you will not receive an additional notice from the Commission on this matter. Adequate responses received on or before this date will be taken into consideration in determining whether audit action will be initiated. **Requests for extensions of time in which to respond will not be considered.** Failure to provide an adequate response by this date may result in an audit of the committee. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action.

Electronic filers must file amendments (to include statements, designations and reports) in an electronic format and must submit an amended report in its entirety, rather than just those portions of the report that are being amended.
