Dear Mr. Adamsky:

This letter is in response to your letter dated October 20, 2021 regarding the report cited above. Your letter indicated that there were entries on Schedule E of the report for which there were not corresponding 24 or 48 hour reports filed.

We believe that some of the difficulty in matching the Schedule E items with those on the corresponding 24 hour reports is caused by the difference between the estimates used to disclose the expenditures initially and the final amounts on Schedule E.
