This letter is prompted by the Commission's preliminary review of the report referenced above. Commission regulations require that these itemized disbursements include the recipient's full name, complete address, date, amount, state of election, office sought (House, Senate, or President), and district (if applicable). Please amend your report to include the state of election, office sought, and district (if applicable). (11 CFR §104.3 (b)(3))

**2.** Schedule B supporting Line 23 of your report discloses a contribution(s) to "Crapo, Michael;" however, you have also disclosed "CRAPO VICTORY COMMITTEE" for this transaction. Please clarify whether this was an earmarked contribution(s) made by your committee through "CRAPO VICTORY COMMITTEE" to this candidate, or if you made the contribution to the political committee exercising no direction or control over how the funds were to be used. If the latter is the case, please do not include the candidate's name on your report. Please amend your report to clarify the ultimate recipient of this contribution(s). (11 CFR §104.3 (b)(3))

Please note, you will not receive an additional notice from the Commission on this matter. Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to
