Dear Mr. Gibson:

In reply to your letter of April 11, 1996, let me elaborate further on our procedures for disclosing contributor information, which is not available at the time original reports are filed, and for disclosing information that was not provided by the contributor, but is available in the committee's records.

As I stated in my previous letter, we make every effort to comply with our requirements to report full information on individuals who contribute \$200 in a calendar year.

With each and every solicitation for funds we request occupation and place of business information from the contributor.

Those who do not disclose this information receive a thank you letter with a postpaid reply envelope requesting this information once again. I have enclosed a copy of the form letter we send to contributors who have not provided the requested information about occupation and place of business.

Our procedure for disclosing contributor information, which is not available at the time original reports are filed is to wait for about 30 days after our 2nd request is mailed and report any additional information we receive either on an amendment to our prior report, or along with our next report.

As for disclosing information that was not provided by the contributor, but is available in the committee's records for the current election cycle, our procedure is to review our records for the current election cycle and report any additional information that was not provided by the contributor.

If you have any further questions regarding our reporting, please do not hesitate to communicate them to me.
