Georgia Power Company Federal PAC Inc. submits this response to the Commission's letter of December 30, 2009, regarding Georgia Power Company Federal PAC's filing on December 16, 2009, of an amended Statement of Organization. In its letter, the Commission indicated that Georgia Power Company Federal PAC's December 16 filing may not have been a complete version of the Statement of Organization as amended, as is required by the Commission's regulations. Georgia Power Company Federal PAC has been advised that the Commission's letter was prompted by the listing in Section 6 of the amended Statement of Organization of Southern Company Employees PAC, and no other political action committees, as an affiliated committee. The amendment filed on December 16, 2009, as well as the amendment being filed today, are complete versions of the Statement of Organization. Georgia Power Company Federal PAC has listed only Southern Company Employees PAC as an affiliated committee in Section 6 in accordance with the Commission's regulation, at 11 CFR Section 102.2(b)(1)(ii)(B), which provides that the separate segregated fund of a subsidiary or subordinate unit of a parent organization need only list as an affiliated committee the separate segregated fund of the parent organization in Section 6. Under the regulation, a listing of the separate segregated funds of other subsidiaries or subordinate units of the same parent organization is not required. Georgia Power Company is the connected organization of Georgia Power Company Federal PAC. Georgia Power Company is a subsidiary of Southern Company, the connected organization of Southern Company Employees PAC. Other Southern Company subsidiaries also sponsor political action committees registered with the Commission. These other committees are affiliated with Georgia Power Company Federal PAC because the connected organizations of all of them are subsidiaries of the same parent company. It is because of the parent/subsidiary status of the various connected organizations that the other affiliated committees have not been listed in Georgia Power Company Federal PAC's Statement of Organization.
