American Future Fund ("AFF") (FEC ID# C30001028) is in receipt of your three Requests for Additional Information dated January 18, 2011, referencing various FEC Form 9 filings.

AFF amended their filings as you requested. With respect to your letter regarding the Form 9 filed on 10/23/2010, the FEC filing number of the amendment is 716720.

In response to your question #1 in reference to FEC Form 9 received on 10/8/2010, this was an amended report as a result from a reduction in the media buy.
