S.C. Johnson & Son Inc. recently undertook an informal audit of S.C. Johnson & Sons. Political Action Committee's ("SCJPAC") filings with the Commission. Our review revealed that SCJPAC inadvertently reported an SCJPAC contribution to the "Restore America Leadership PAC" as made to Senator Sam Brownback's re-election campaign on our *30 Day Post-Election Report* of 2000.

We have included with this letter an amended *30 Day Post-Election Report* for that period correcting that administrative reporting error. We have contacted both "Restore America Leadership PAC" and Senator Brownback's re-election campaign, both of which reported the contribution correctly. Thus, the error was SCJPAC's alone and no amended filings are required from these other two committees.
