This letter is prompted by the Commission's preliminary review of the report(s) referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. **An adequate response must be received at the Commission by the response date noted above.** An itemization of the information needed follows:

-Schedule 9-B of your FEC Form 9, received 9/29/06, discloses disbursements that were made and communications that were publicly distributed outside of the coverage dates. This report should include only disbursements made and communications publicly distributed between 9/28/06 and 9/29/06. Please amend this report and any previous or subsequent reports so that all activity is disclosed in the report covering the period in which the activity occurred. (2 U.S.C. § 434(b))

-Schedule 9-B of your FEC Form 9, received 9/29/06, discloses an additional public distribution(s) of a previously reported electioneering communication(s) but reports a communication date that is the same communication date as the initial public distribution. The first notice filed with regard to a particular electioneering communication must disclose the date that the communication was first publicly distributed. If a previously reported electioneering communication was publicly distributed an additional time, you must disclose the communication date of the additional public distribution, provided that the cost related to the additional public distribution(s) exceeds \$10,000. (11 C.F.R. § 104.20(c)(6)) Please amend



Please note you will not receive an additional notice from the Commission on this matter. Adequate responses received on or before this date will be taken into consideration in determining whether audit action will be initiated. **Requests for extensions of time in which to respond will not be considered.** Failure to provide an adequate response by this date may result in an audit of the committee. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action.

Electronic filers must file amendments (to include statements, designations and reports) in an electronic format and must submit an amended report in its entirety, rather than just those portions of the report that are being amended.
