Dear Treasurer:

This letter is prompted by the Commission's preliminary review of the report referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. **Failure to adequately respond by the response date noted above could result in enforcement action.** Additional information is needed for the following 2 item(s):

1. Your amended report discloses an increase in receipts totaling \$14,000 from the amounts disclosed on your original report. Please amend your report or provide clarifying information as to why this activity was not disclosed on your original report. (11 CFR § 104.3)
2. Line 17 of the Detailed Summary Page discloses \$14,000 in Other Federal Receipts for which there is no corresponding Schedule A. Any of these receipts that are made to your committee by a single source, which in the aggregate are in excess of \$200 for the calendar year must be itemized on a Schedule A. Please provide a Schedule A or provide an explanation for this apparent discrepancy. (52 U.S.C. §30104(b)(2)(J) (formerly 2 U.S.C. §434(b)(2)(J)) and 11 CFR § 104.3(a)(4)(vi))

**Please note, you will not receive an additional notice from the Commission on this matter.** Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. **Requests for extensions of time in which to respond will not be considered.**
