Dear Mr. Buckley:

This letter is in response to your correspondence dated October 25, 2006. As you noted in your correspondence, Edward Jones PAC made multiple contribution to each of Ben Cardin, candidate for Senate from the State of Maryland, and Ben Nelson, candidate for Senate from the State of Nebraska.

We have enclosed with this letter copies of the correspondence and checks with respect to the contributions to Mr. Cardin. You will note that the contributions were appropriately attributed or designated when made. For your information, the \$2,000 contribution made on January 5, 2006 was attributed to the next scheduled election, the primary. The \$1,000 contribution made on September 11, 2006 was directed to Mr. Cardin's primary election, specifically and in writing. The \$4,000 check dated September 11, 2006 was designated for the general election.

With respect to the contributions to Mr. Nelson, the \$2,000 contribution made on January 3, 2006 should appropriately have been credited to the primary election. The subsequent \$5,000 contribution made on August 2, 2006, a date which was after the conduct of the primary election, was intended for the general election. Given the rule that all contributions are credited to the next scheduled election, no specific designation was required with respect to either of the contributions made to Mr. Nelson.

We note that our reports designated each of the contributions referenced above as G2006. We have amended our filing electronically to reflect the primary election designation for the three primary election contributions. Should you have any questions, please do not hesitate to call.
