This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-Schedule H4 of your report discloses a disbursement(s) to Boatmans Bank for interest payments on Line of Credit. Please be advised that interest payments on loans do not qualify as shared expenses to be allocated between your federal and non-federal accounts. All interest payments should be disclosed on a Schedule B supporting Line 21(b) of the Detailed Summary Page. Any reimbursement from your committee's non-federal account for any portion of this disbursement(s) is not permissible. 11 CFR §102.5(a)(1)(i)


The Commission recommends that you immediately transfer the funds received by your federal account as reimbursement for the non-federal portion, back to your non-federal account. Although the Commission may take further legal action concerning this prohibited activity, your prompt action will be taken into consideration.

-Schedule A supporting Line 11(a)(i) of your report discloses a receipt(s) from Ticket Sales. Please be advised that federal regulations require the itemization of all contributions from individuals/persons that aggregate greater than \$200 in the calendar year. If this figure includes any receipts that aggregate greater than \$200 from an individual/person, please amend

your report(s) by itemizing the receipts on Schedule A. 11 CFR  
§104.3(a)(2)

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter.
