This is in response to your letter dated September 7, 2007 asking for clarification on expenditures made for "State Quarters Fundraiser - Coins" and "State Quarters Fundraiser - Sales Tax" on Schedule B.

Our State Quarters Fundraiser is a fundraiser whereby we purchase uncirculated state quarters and collector's boxes which hold the entire collection of coins. We purchase these items through MPI Coin and sell them to our members with a portion of each sale benefiting the Federal Credit Union Legislative Action Fund (Federal CULAF).

Checks are written to MPI Coin for the uncirculated "coins" and to the Washington Credit Union League (our affiliated organization) for "sales tax" on the collector's boxes which are subject to state sales tax.

None of the State Quarters Fundraiser expenditures are made on behalf of specifically identified federal candidates.


Please note, you will not receive an additional notice from the Commission on this matter. Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. **Requests for extensions of time in which to respond will not be considered.**

Electronic filers must file amendments (to include statements, designations and reports) in an electronic format and must submit an amended report in its entirety, rather than just those portions of the report that are being amended. If you should have any
