If you take the highest average contribution of \$2.82 and multiply by 12 months the average total contribution per member per year is \$33.84.

PAC monies are deducted from the members' paychecks at a rate of \$.035 per hour worked. If you work 40 hours a week your PAC contribution would be \$1.40 weekly, and \$72.80 yearly.
