This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-Line 28(a) of the Detailed Summary Page of your report discloses a total of \$31,885 in Refunds of Contributions to Individuals. The sum of the entries itemized on Schedule B, however, indicate the total to be \$23,125. Please amend your report to clarify this discrepancy and ensure that all refunds of receipts from corporations have been properly disclosed.

-Schedule B supporting Line 28(a) discloses refunds made to apparent corporations (pertinent portion(s) attached); however it appears that the receipt of these contributions have not been reported by your committee. Please provide the original date of receipt of these contributions. In addition, you must amend the report covering the period during which the contributions were received to disclose the receipt on Schedule A supporting the appropriate line of the Detailed Summary Page. 11 CFR § 103.3(b)(1)

A response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter. Electronic filers must file amendments (to include statements, designation and reports) in an electronic format and must submit an amended report in its entirety, rather than just those portions of the report that are being amended. If you need
